- **Prize description:** A Travel Gift Certificate with ***Serendipity Travel Agency, LLC/Serendipity Travel by Cathy*** valued at \$5,000 to be used toward travel only, no cash value, not redeemable for cash. (**PRIZE DETAILS below**)

- **Federal mail warning:** Depositing raffle tickets or related materials via the U.S. Postal Service is a violation of federal law and carries criminal penalties.
- **Charitable allocation:** All proceeds from raffle ticket sales benefit the healthcare mission of Notre Dame Health Care
- **Raffle Permit Issued by:** City of Worcester, MA
- **OTHER:** All raffle tickets purchased must be completely filled out with all buyer contact information and be signed by **both** the buyer and the seller in order for the entry to be valid. ***Make checks payable to: Notre Dame Health Care, "Raffle" in the memo.***

TAX DISCLOSURE INFORMATION

- **Ordinary income notice:** The prize is considered ordinary income to the winner for federal and state income tax purposes.
- **State Tax Withholding:** MA law mandates a 5% state income tax withholding which is \$250 (5% of \$5,000 prize value) collected from the winner before prize is issued. Winner's contact information and TIN/SS will be required in order for NDHC to file, pay withholdings and issue the winner a W-2G. Winner will be required to pre-pay MA Department of Revenue withholdings to Notre Dame Health Care prior to receiving the prize. W-2G to be sent to winner by 1/31/2027.
- **Tax deduction notice:** No part of the \$50 ticket purchase is considered a charitable contribution by the IRS.
- If winner does not make arrangements to claim the prize and pay the required tax withholding within 10 days of the drawing, the prize will be forfeited and an alternate winner will be drawn.
